Clubs to be allowed to enter 2 men's teams where possible into the County Club League from 2027 season. Should Clubs enter 2 teams and they are drawn in the same league, their first fixture should be against each other.

If the Exec amendment is not passed the delegates will vote on the original proposal.

<u>Proposal 2</u>: The $3^{rd}/4^{th}$ place playoff be discontinued in both Men's and Women's County Club League Finals.

It is felt that this detracts from the 2 finals being played at the same time and is unfair on those players playing in the Final.
